## RAY ALLEN AWARD FREQUENTLY ASKED QUESTIONS (FAQs)

#	TOPIC	QUESTION	ANSWER
1	QUALIFICATION	I served as Lieutenant Governor more than once, but never for two consecutive terms. When does my qualification begin?	<p>The sixth year after the end of your first term.</p> <p>Assuming you served for years 1997-1998 then 2002/2003 then 2007/2008, you qualify in the 6<sup>th</sup> year after your first term, that is during year 2003/2004. Depending on the year you are nominated for the award, service during year 2007/2008 could earn you some points.</p>
2	QUALIFICATION	I served as Lieutenant Governor for two back-to-back two-year terms (total 4 years straight). When does my qualification begin?	<p>The sixth year after you ceased to be Lieutenant Governor.</p> <p>If for example you served as LG for years 2010/2011; 2011/2012; 2012/2013 &amp; 2013/2014, your qualification would begin during year 2020/2021.</p>
3	QUALIFICATION	I served as Lieutenant Governor during year 2011/2012. I am being nominated for the Ray Allen Award during year 2019/2020. Can I include on my nomination activities I participated in during my presidency year (1992/1993) and after but all before 2011/2012?	<p>No.</p> <p>It is better that you DO NOT include these. If you do, you WILL NOT receive any credit for these.</p> <p>Please refer to the Purpose and Qualification statements for the Ray Allen Award. You will find it at the top (first page) of the Nomination document.</p>
4	APPLICATION	Why do I have to fill out a structured Form to be nominated for the Ray Allen Award?	<p>The structured nomination form is prepared and paired to a structured scoring document with prescribed points allocated for each question.</p> <p>It follows that should you submit a different nomination document, your entry risks disqualification and non recognition.</p>
5	APPLICATION	Why am I not allowed to submit my nomination directly to the EC&C District PLG Committee?	<p>The Rules allow for and require ONE nomination (entry) per Division in EC&amp;C District per year.</p> <p>The out working of this rule is that all nominations are to be routed through the relevant division's divisional council meeting (DCM) and serves at least two purposes.</p> <ul style="list-style-type: none"><li>• It creates a runoff among candidates of the same division allowing the best (at the time) to come up to the District level.</li></ul>

			<ul style="list-style-type: none"> <li>Allows for divisional authentication of each nominee – hence the need for the Lieutenant Governor to sign and to state the date of the DCM.</li> </ul>
6	APPLICATION	When do we apply for this Award	<p>The annual Nomination period opens circa 1 December annually and closes on or around March 31 annually.</p> <p>It is anticipated that each division will hold at least one DCM within this 4-month window and hence will be able to approve and authenticate a single nominee per division to go forward.</p> <p><b>Please carefully follow the directions on the Nomination Form.</b></p>
7	DISSEMINATION OF RESULTS.	Does the PLG Executive publishes the results?	<p>No.</p> <p>The PLG Executive Committee does 3 things at the award ceremony: -</p> <ul style="list-style-type: none"> <li>Recognize ALL Nominees from the respective divisions.</li> <li>Congratulate ALL Nominees.</li> <li>Announce the winner and present the award.</li> </ul> <p>The PLG Executive Committee works diligently to preserve the absolute integrity of the process and seeks to avoid any unauthorized or premature release of relevant information.</p>
