2018 - 2019 Dues

Annual Dues

On October 1, 2018 Kiwanis International will begin to prepare the annual dues invoice. This is an invoice for the club based on the number of members in the club as at midnight September 30, 2018 less any members deleted up to midnight October 10, 2018.

The invoice consists of four charges

- 1. Annual KI dues
- 2. KI magazine English Canada only
- 3. KI Insurance Liability & Directors and Officers
- 4. District Dues

The first three charges are in US\$ and the fourth in Canadian. The amounts shown have been converted to local currency.

There has been no increase in Kiwanis International dues or District dues however, the currency exchange and District rebate will affect the actual amount due.

Currency exchange was set on July 31, 2018 at 1.30 (1.25 last year)

The ECC rebate* was set at \$2.50 (\$5.00 last year)

NOTE: the ECC rebate has already been applied on the invoice. (\$36.00 - \$2.50 = \$33.50)

KI Dues and the KI magazine must come from the club's administrative account

District Dues: \$5 can be paid from service account and \$28.50 should come from the admirative account

KI Insurance can be paid from the club's administrative or service account. this payment is for both Liability and D&O coverage

All Caribbean clubs pay directly to Kiwanis International in US\$. Caribbean clubs send the payment to Kiwanis international in the USA

All Canadian clubs pay to Kiwanis International in Canadian \$. Canadian clubs send the payment to a P.O. Box in Toronto

* the District Dues are \$36. Over the past three years the District Board has provided rebates to cushion the effect of US exchange. For 2018-2019 a \$2.50 rebate has been approved.
